23/24 /165 **PRESENT** - Cllrs Barnett (in the Chair), Pople, Salter, Thompson and Hall.

- 23/24 /166 **ALSO PRESENT** 5 members of the public.
- 23/24 /167 **IN ATTENDANCE** The Clerk to the Council.
- 23/24 /168 **APOLOGIES** none received.
- 23/24 /169 **DECLARATIONS OF INTEREST AND CONSIDERATION OF ANY DISPENSATIONS REQUIRED** - Cllr Pople declared an interest in the Play Area as she is the Council's representative on the committee. Cllr Thompson declared an interest in the CVA as his wife is treasurer and he is the publicity officer.
- 23/24 /170 MINUTES OF PREVIOUS MEETING were confirmed and signed.
- 23/24 /171 UPDATES ARISING FROM PREVIOUS MEETINGS AND NOT LISTED none.
- 23/24 /172 SOMERSET COUNCILLORS' REPORTS neither Somerset Councillor was in attendance.
- 23/24 /173 LCNS AND ANY ACTIONS REQUIRED Cllrs Barnett and Hall and the Clerk had attended a recent meeting in Shapwick and a short report was given. No Highways representatives were in attendance but a representative from Kier led the meeting and was informative as far as his side of things went.
- 23/24 /174 **BOUNDARY COMMISSION ELECTORAL REVIEW** had been circulated to all councillors.
- 23/24 /175 **RURAL AFFORDABLE HOUSING** this had been circulated to all councillors. It was agreed that affordable housing for the community would be a good thing. However, it needed land and a developer to bring it about.
- 23/24 /176 **DEVOLUTION** as far as local devolution is concerned there is still no proper indication of what is on offer.
- 23/24 /177 HIGHWAYS:
  - a. <u>Bridge refurbishment</u> Cllr Salter reported that the work should be undertaken soon.
  - b. <u>Outstanding highways issues</u> the drains in Old School Lane are already blocked again with stones and grit having been washed into the pipework. No water can flow down the system at present.
  - c. Enhanced Highway Maintenance (EHM) Covered under LCNs.
  - d. <u>Mini bus parking at School and 30mph repeater signs</u> following discussion it was agreed that the Clerk should write to the School Transport department at County Hall letting them know that, on safety grounds, it is necessary that the minibuses arrive from 3.40pm and should not arrive before then due to lack of space, on road parking problems for pedestrians and children hidden by the minibuses. She would let the school know of the letter/email.
  - e. <u>Problems arising</u> a pot hole in Manor Road and a sink hole in Manor Road. A member of the public would send the Clerk a what3words location for both sites. A tree branch causing concern would be reported.
- 23/24 /178 **FLOODING** There is currently the possibility of some grant aid to assist with flooding problems in villages. Cllr Thompson would draft a grant application for consideration at the January meeting. The Clerk had collected literature relating to flooding when she attended the SALC/SC conference. This was passed to Cllr Thompson.
- 23/24 /179 **RIGHTS OF WAY/FOOTPATHS TREES ON SCHOOL FOOTPATH -** Cllr Thompson mentioned that a tree not originally identified had fallen on the School field fence. This has already been cleared away.
- 23/24 /180 **PLAY AREA REPORT** Cllr Pople reported that takings from the Fayre were a bit down this year at £350. The committee will consider alternative events for future fund raising events.
